1. The minutes for the March 3, 2005 EDST faculty meeting were submitted and approved.

**New Business**

2. Presentations by Invited Guests.
  - a. Judy Nixon, HSSE Librarian, reported on the *Missing Books Project*. The HSSE Library has undertaken a project to locate books missing within the Library; Ms. Nixon reported that many books that were lost had been located and returned to their appropriate places. A second round of searching and relocation will be undertaken in the near future.
  - b. Jennifer Jeffries, the new College of Education Director of Development, introduced herself and invited faculty members to visit her office to share information about their teaching, research, and engagement agendas.

3. EDST Awards – Kevin Kelly  
2004-05 departmental awardees in the areas of teaching/learning, discovery, and engagement were recognized. Each faculty award winner will receive an additional \$50 in supply and expense funding for the 2005-06 academic year. The EDST award winners are:

Outstanding Graduate Student Teacher – **Lisa Duffin**: Lisa has received very positive evaluations from her Block II students. Her students appreciate her enthusiasm for the teaching profession, her active involvement in the learning process, and her dedication to student learning.

2004-2005 EDST Faculty Discovery Award – Assistant Professor Level: **Helen Patrick**: Professor Patrick's research is outstanding in both its quality and quantity. Her publication record includes more than 20 refereed journal articles and 8 book chapters on motivation theory. She is the recipient of three Spencer Foundation grants. Helen's work is widely cited in prominent research journals

and educational psychology texts. She is one of the most promising young scholars in the field of educational psychology. We're very pleased that she is a member of our department.

2004-05 Outstanding Faculty Discovery Award - Associate Professor Level – **Susan Maller:** Professor Maller has consistently demonstrated a high level of research productivity, evident in her NSF-funded collaborations with the Department of Engineering Education, her publications in texts such as the *Assessing Deaf and Hard of Hearing Adults*, her review work for the *Mental Measurements Yearbook*, and her contributions to prestigious scholarly conferences such as the International Test Commission Conference and The International School Psychology Conference. Susan is a wonderful model of collaborative scholarship; we're proud that she is a member of our department.

2004-05 Outstanding Faculty Discovery Award – Professor Level – **Sydney Zentall:** Professor Zentall has made a lifetime of contributions to the study of the learning and behavioral problems of students with attention deficit disorder. Sydney has just completed *ADHD and Education*, a book that will be a major contribution to the field of education. Sydney was the Keynote speaker for the 2004 Hawaii International Dyslexia Association conference in 2004. Her expert scholarship is a wonderful reflection of the quality of research conducted in Educational Studies.

2004-05 Outstanding Faculty Service Award – **Jean Peterson:** Professor Peterson is a model of faculty service. In 2004 alone, she served as the chair of the NAGC Counseling and Guidance Division, was an editorial reviewer for the *Professional School Counselor*, *Gifted Child Quarterly*, and *Roeper Review*; was a guest editor of an issue of *Professional School Counselor*, was the President of the Indiana Counselor Education and Supervision association, and was program coordinator for the school counseling program. Jean Peterson has served tirelessly at all levels. We are all enhanced by her dedicated service.

2004-05 Outstanding Teaching Award – **Sidney Moon:** It is very fitting that our Associate Dean for Learning and Engagement is being honored with a teaching award. Professor Moon has taught many courses in our department, but is best known for her work in courses such as EDPS 540 Gifted, Creative, and Talented Children and her EDPS 631 Seminar in Gifted Education. Sidney's students laud her great depth of knowledge of her field, appreciation for the balance of science and practice, and dedication to meeting the learning needs of gifted students. Sidney, you are a fine model of teaching for all of us.

3. Appreciation of a Departing Faculty Member – Karl Kwan. Karl Kwan came to our department in 1996 having just completed his Ph.D. in counseling psychology at the University of Nebraska. He quickly established a national reputation for his research on the psychological adjustment and assessment of U.S. racial and ethnic minorities and immigrants. Karl published in excellent journals such as *Educational and Psychological Measurement* and was a frequent reviewer for the *Mental Measurement Yearbook*. He is an associate editor for *The Counseling Psychologist*. Karl will be remembered by students for his outstanding work in teaching the EDPS

*507 Counseling Multicultural and Diverse Populations* course. Students had the rare privilege of learning from someone with research and clinical expertise in culture and diversity issues. Karl made numerous and unselfish contributions to the development of the counseling psychology program and to the ultimately successful APA accreditation effort.
